A. Introduction

Welcome to the Resonate Voice and Speech Services LLC ("Resonate" or the "Company") website, which is operated on a Wix.com, Ltd. platform. Teletherapy and/or in-person speech therapy sessions are recommended for individuals seeking voice and speech therapy to address a medical diagnosis. With real-time virtual or in-person sessions you are working face-to-face with the clinician and will receive individualized, professional feedback to help you refine and appropriately apply your new skills. This ensures you are mastering the techniques that help heal and/or improve your voice or symptoms. It is strongly advised that those who have a medical diagnosis and are healing from vocal injury should receive this type of direct patient care.

Professional voice training sessions provide education, strategies, and exercises rooted in voice science and pedagogy to maintain optimal vocal function, help prevent future strain or injury, and address vocal characteristics like resonance and tone. Voice training teaches techniques and vocal health through one-on-one, virtual or in-person sessions tailored to your career and voice goals to promote vocal health and wellness and improve your quality of life personally and professionally. These sessions are non-medical and are available to anyone world-wide.
